The Challenge

A regional health plan* in the Southeastern United States recognized that outdated provider information was costing them money and sabotaging efficient operations. Despite these efforts, the health plan continued to make payments to incorrect addresses, re-issue checks returned as “undeliverable” at a cost of approximately \$20 per transaction, pay fines for making payments to sanctioned doctors, and frustrate members with outdated and inaccurate provider directories.

The Results

Enclarity reviewed 101,565 records for the health plan. Typically, Enclarity's experience is that 35-40% of provider records contain errors or omissions. In this case, Enclarity found that 50% of the records required updating by ProviderPoint. For this health plan, ProviderPoint found:

- 310 of the physicians in the database were deceased
- 3% of records were provider duplicates – with the same address and taxpayer identification number (TIN)
- 29% of records needed address updates
- 21% of records needed augmentation of a variety of fields, including incorrect addresses, incomplete phone numbers, names with expired licenses, inconsistencies between licenses and DEA numbers

The health plan's newly cleaned provider files provide the plan with numerous benefits, including:

- An accurate provider database that is constantly updated
- Reduced expenses through reducing re-issue check costs and processing costs of manual claims
- Improved efficiency through increased auto-adjudication of claims, network quality, reduction of customer and provider call volume and handle time, and improved outcome reporting and analysis
